5.1. Changes by the Respondent to its submission will not be considered after the closing date and time.

6. PRICING

6.1. All prices must be quoted in South African Rand on a fixed price basis, including VAT.

7 BINDING OFFER

7.1. Any Quotation furnished pursuant to this Request shall be deemed to be an offer. Any exceptions to this statement must be clearly and specifically indicated.

8 DISCLAIMERS OF MORETELE LOCAL MUNICIPALITY

- 8.1.1. Modify the RFQ's goods / service(s) and request Respondents to re-bid on any changes;
- 8.1.2. Reject any Quotation which does not conform to instructions and specifications which are detailed herein;
- 8.1.3. Disqualify Quotations submitted after the stated submission deadline;
- 8.1.4. Not necessarily accept the lowest priced Quotation or an alternative bid;
- 8.1.5. Bids lodged at the incorrect venue that reach the correct venue late will be regarded as late.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.



2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
